Meeting date and Location

The World Mission Board of Directors Meeting held via TEAMS online services April 30, 2024 7 PM Central Time

Present

Pastor Earl Korhonen, Wanda Jacobson, Pastor Craig Johnson, Dr. Lyle Mattson, Ken Sletten, Pastor David Johnson, Pastor Jerry Nelson and Bill Sheldon.

Meeting Called to Order

The meeting was called to order by Chairman Craig Johnson.

Devotions

Pastor Craig opened in prayer.

Purpose of Meeting

To consider the request from the Raan's received by e-mail.

Pr. Craig generalized the issues with the Raan family and summarized the email received from the Raans to the Board.

Current furlough time is through Oct.

The Raans are asking for Sept/Oct to return to Uganda.

The Raans are asking for AFLC missionary status through the end of the year.

The Raans are asking for two areas of action. Timing for their return to Uganda, and a decision on their resignation or the possibility of remaining on staff as "missionaries on loan."

There was discussion as to the Raans finances and the necessary time needed to close out their ministry in Uganda. The discussion covered a variety of issues surrounding the Raans and their ministry - past and future.

202416 MSC DJ/JN to cover the Raans salary through the end of their granted furlough season of October 2024.

202417 MSC KS/DJ to allow a trip back to Uganda, the expenses of which would be taken from their personal support

The board then discussed what is meant by "on-loan." Wanda posted the articles of the handbook related to "on-loan" missionaries. The "on-loan" section of the handbook was reviewed and it was decided that the Raans would not qualify as "on-loan" missionaries in this situation. The option to resign would therefore be the best course of action for the Raans. This

will be communicated to Brent ASAP. The handbook requests the missionary to submit a letter or email of resignation 3 months prior to completion, which in this case would be no later than August 1.

Details of this transition will be discussed with the Raans by Pr. Craig Johnson.
